A. INTRODUCTION

A.(i.) BACKGROUND

One of the world's great gardens, Longwood's story is one of legacy, innovation, and stewardship. Our Gardens are a living expression of all that our founder, Pierre S. du Pont, found inspiring, meaningful, and beautiful. From the intricate fountain systems to the meticulous gardens to the architectural grandeur, awe-inspiring discoveries await at every turn.

In 1906, Mr. du Pont purchased the Peirce Arboretum to save its trees from being cut for lumber. Over the next nearly half century, Mr. du Pont developed Longwood Gardens into what it is today, a magnificent horticultural showplace.

Longwood Gardens now encompasses over 1,100 acres of gardens, woodlands, and meadows. With over 11,000 types of plants, unique fountain displays, educational and visitor programming, 400 performances a year, and an annual attendance of over 1,600,000, Longwood is an active public garden and a significant economic force in the greater Philadelphia region. Longwood Gardens is recognized as a vital part of the thriving arts and cultural community and a leader in public gardens.

Longwood has achieved "gold standard" status among public gardens worldwide. It is renowned for its stately grounds, superb horticultural displays, accomplished staff, and innovative programs. Together with our forward-looking President/CEO, the Board of Trustees began the process of planning Longwood's future. In 2008, Longwood engaged Lord Cultural Resources to facilitate the development of a Visionary Master Plan that would guide the development of the garden. Through a comprehensive and inclusive process, Longwood established its long-range vision and strategic goals to assist in realizing this vision. Additional strategic plans were initiated to continue to evolve the Gardens in 2016 and again in 2023. Longwood is once again embarking on a comprehensive planning process to further position us as one of the world's most influential gardens and cultural organizations. This initiative incorporates a new strategic plan, a refreshed site master plan, and a business plan.

This vision is expressed in Longwood's foundation statements, which are included below.

Longwood Gardens is the living legacy of Pierre S. du Pont bringing joy and inspiration to everyone through the beauty of nature, conservation, and learning.



Vision Statement:

We envision a world where beauty is accessible to all. We are leaders and innovators in the art and science of horticulture. We present extraordinary experiences to bring pleasure, foster well-being, and spark imagination. We enrich society through learning and training programs, research, stewardship of the land, and community engagement.

A.(ii.) INSIGHTS & OBJECTIVE

The results of Longwood's various planning efforts are qualitatively and quantitatively significant. Today, Longwood is positioned as a 21st century leader in experiential horticultural training, horticultural conservation, and public garden best practices. Included within the daily operation of Longwood Gardens is the patrol, monitoring and response through our Public Safety Division.

The Longwood Public Safety and Security Division provides responses to visitors, staff, and residents, operating 24/7, 365 days a year. The division patrols, monitors, and responds to incidents outside of normal operating hours, with its current vehicles averaging 13.5 hours per day of use. As such, Longwood is proposing to acquire new security fleet vehicles.

Longwood Gardens began a strategic initiative several years ago to standardize the fleet to Ford vehicles. This includes an investment in a Factory Ford diagnostic tool, which requires an annual subscription fee to keep the Ford tool operable and current, membership in the Ford Fleet Network, and an inventory of some Ford products/parts for in-house maintenance. Additionally, the Longwood Gardens maintenance personnel are highly qualified and experienced working with and repairing Ford vehicles.

The current Public Safety and Security Division fleet of vehicles includes two Ford F150 pickup trucks, two Ford Explorer/Police Interceptors, and overall, of the 82 on-road vehicles in the entire Longwood Gardens fleet, a total of 69 of those are Ford brand vehicles.

Longwood Gardens is a Delaware non-profit corporation, tax-exempt under IRC Section 501(c)(3) and organized as a private exempt operating foundation. Longwood is seeking proposals from qualified firms to provide that include:

- All vehicles and other service items must be most current year, make and model.
- All Vehicle Exterior Color should be Oxford White or equivalent.
- All trucks must include protective "Backrack" (or equivalent) unit Aluminum Body Style No Drill Hardware Kit.
